What is the overall <u>deductible</u> ?	In-Network <b>\$1,500</b> person/ <b>\$4,500</b> family. Out-of-Network <b>\$1,500</b> person/ <b>\$4,500</b> family.	Generally, you must pay all the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u> ?	Yes. <u>Preventive care</u> services, inpatient facility and all MH/SU inpatient services are covered before you meet your <u>deductible</u> .
