NCDHHS

The NC State Laboratory of Public Health (NCSLPH) can perform testing for the virus that causes coronavirus disease 2019 (COVID-19), which allows NCDHHS to promptly identify and respond to any potential cases. Only those who meet the following criteria should ask their doctor or local health department about being testing for COVID-19: Have fever or lower respiratory symptoms (cough, shortness of breath) and close contact with a confirmed COVID-19 case within the past 14 days; OR have fever and lower respiratory symptoms (cough, shortness of breath) and a negative rapid flu test

At this point in time, widespread testing for the COVID-19 virus is not available. We anticipate testing will be more broadly available in the coming days and weeks, however, it will likely only be offered to those who have symptoms and fit in the travel or exposure categories as determined by the CDC. It will require an order from a physician based on the screening criteria and symptoms. At this time, there is no reason to go to an urgent care or doctor's office and ask to be tested. If the criteria listed above has been met, and your providers have reason to believe you are at risk, they will request testing on your behalf.
